

### **1. FOCUS ON SCHOOLS - NEXT GENERATION EU**

#### Actions to prevent and combat early school leaving

These actions consist in the **design and implementation of** *mentoring* **and** *orientation* **paths**, paths to **strengthen basic skills**, **motivation** and tutoring, **orientation paths for families**, training courses and co-curricular workshops, provided for learners at risk of early drop out.

We are working with schools on a shared project that sees the use of the Orienta Express Young path as a catalyst for motivation through the following actions:

- OE token administration

- One to one orientation

- Group workshops on strengthening motivation and personality

<u>- Laboratories of active job search and involvement of companies promoting the lowering of skill mismatch with a focus on emerging professional profiles and new market opportunities</u>

- Parental involvement thanks to seminars on the issues of parental responsibility
